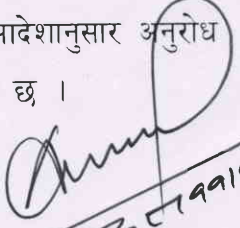

Australia Awards Scholarships Information Seminar for Government of Nepal Officials

Dear Mr Lamsal

I am pleased to inform you that applications for Australia Awards Scholarships for study commencing in 2023 are now open and will close on 29 April 2022. Australia is pleased to continue its support to long term capacity development in Nepal through Australia Awards. Over the last 60 years, more than 1,100 Nepalese have benefited from Australia Awards Scholarships, Fellowships and Short Course opportunities.

I would like to take this opportunity to thank the Ministry of Foreign Affairs (MOFA) for the support provided in different stages of the Australia Awards cycle. In July 2021, for example, MOFA's Mr Krishna Chandra Aryal represented Government of Nepal in the Australia Awards Selection Interview Panel for Scholarships commencing in 2022. I am pleased to inform you that the panel nominated 20 applicants, including 11 public service officials, as successful candidates. They will commence their study in June 2022 along with 10 other nominated applicants from previous two selection rounds, subject to Australia's border requirements.

There are eight priority sectors identified for this round of application: Disaster Risk Reduction; Economic Development, Education; Gender Equality, Disability and Social Inclusion; Governance; Health; Natural Resource Management and Sustainable Infrastructure Development. These priority sectors are built on Nepal's development priorities as outlined in its periodic plan.

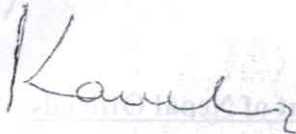
Consistent with our commitment to inclusion, women, people with disability and people from traditionally marginalised groups are encouraged to apply. All candidates will undergo a merit-based selection process.

To provide the prospective applicants with relevant information, the Australia Awards team is organising online information sessions. A separate online session is being organised exclusively for civil service officials at the Ministry of Federal Affairs and General Administration (MoFAGA) on 25 February 2022. 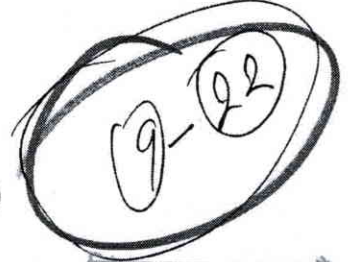

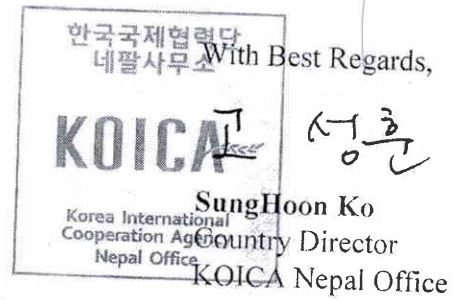

4. Qualifications

Prospective applicants must meet all of the following conditions.

- (1) **Citizenship:** Be a citizen of the Scholarship Program target country.
- (2) **Government Nomination:** Be officially nominated by their governments.
 - Be a government employee. With a minimum of 2 years of experience in the field of study
 - * Exception 1 - Applicants with an 'international NGO' background may apply for the program with two letters of recommendations:
 - Your government office; and
 - Korean Embassy, world widely known NGO, an UN-associated organizations, or the KOICA Organization within your region
 - * Applicants with 'international NGO' background are only able to apply for KOICA-AJOU Master's Degree Program in Civil Society Leadership
- (3) **AGE:** (Preferably) Be under age 40 as of February 1, 2022.
- (4) **Health:** Be in good health, both physically and mentally.
 - Those with disabilities, but in good mental and physical health, are eligible to apply.
 - Those with severe illness are NOT ELIGIBLE to apply.
- (5) **Level of Education:** Have a completed Bachelor Degree or an equivalent to college / university level Educational background.
 - * Some program have specific qualifications in terms of level of education, and refer to Program Information of each program.
- (6) **English Proficiency:** Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and theses in English.
- (7) Not be a person who has withdrawn from KOICA's scholarship program.
 - * Person belonging to the institution in which candidates submitted false documents and returned to his / her country arbitrarily in the middle of SP program cannot apply.
- (8) Have not participated in KOICA scholarship program or any of the Korean Government's Scholarship Program before.
